## Rally Protesting Unconstitutional Ad Valorem Property Taxes in support of Public Education

For the first time in 44 years we have an opportunity to impact the results of a lawsuit brought by 400 Texas State School Districts to stop funding of a State Function by a means unlawful to the State. Public Education is a State Function under Article. 7 Section 1 Texas Constitution (Tex. Con.) and Texas Education Code (TEC) §42.001(a) and it must be "substantially" paid for by the State. Substantially means 100% or very close to it.

The State of Texas is forbidden to levy an Ad valorem property tax on any property in the State of Texas under Art. 8 Sec. 1-e. A Texas School District is considered a subdivision of the State of Texas and is also considered the State of Texas under the Texas Civil Practice and Remedy Code (TCPRC) §101.001(3)(A)(B). This means the local Texas School District is the State of Texas and therefore may not impose an ad valorem property tax on any property in Texas to support public education. Further, a subdivision of the State of Texas cannot have more power than the State of Texas. This also means the local school district cannot impose an ad valorem property tax on any property in Texas.

We now also know that the courts will not let any citizen or group of citizens challenge the constitutionality of the ad valorem property tax imposed by school districts to support public education unless they can show a unique injury separate from all their other fellow citizens of Texas. This is not possible, so the citizen is denied their constitutional rights in violation of Art 1 Sec. 13 & 29. This corruption of the Texas Judiciary forces the citizens into the street or the Legislature. But the Legislature is controlled by the 10 New York banks that benefit from the unlawful bonding of the citizens to pay for public education in Texas to the present amount of \$106.8 Billion. There should be no debt at all for public education!

That leaves the street! So we are taking it to the street, all around the Travis County Courthouse just off the southwest corner of the Capitol in Austin, where the trial will begin this coming Monday morning October 22, 2012. The object is to wake up the "officials" in Austin, Texas to the fact that we know the multi-Trillion dollar scam they have been running on us for 44 years. The lawsuit going on inside is irrelevant as none of the questions brought by the districts challenge ad valorem property taxation in support of public education. They only want the booty split up more evenly among the pirates. Our focus is to draw attention and educate all who cross our path that day including the media that will be there in full force.
